## IMPORTANT INFORMATION

- ✓ **RV / TRAILER APPLICATIONS WILL BE ACCEPTED STARTING MARCH 18, 2019. APPLICATIONS FOR LOTTERY MUST BE RECEIVED BY THE OFFICE NO LATER THAN APRIL 1, 2019 AT 12 NOON.**
- ✓ **A COMPLETED APPLICATION INCLUDES, A SIGNED COPY OF THE RULES & PROCEDURES, THE APPLICATION FILLED OUT AND THE APPLICABLE PAYMENT FOR THE RV SPACE FEE.**
- ✓ **THE 2019 FAIR WILL OFFER 175 AVAILABLE RV SPACES IN COMPARISON TO LAST YEAR'S 150 AVAILABLE SPACES, SO SPACE AVAILABILITY SHOULD NOT BE A LIMITING FACTOR THIS YEAR.**
- ✓ **THE GARDEN HIGHWAY RV LOT WILL NOT BE AVAILABLE FOR THE 2019 FAIR.**

## TWO AVAILABLE RV AREAS

### 1) The North RV Dry Camp Lot: (Details include)

- Located on "C" Street: 125 available spaces
- Cost: \$275
- One (1) 20' wide RV Space
- One (1) Vehicle Parking Pass in the North RV Lot
- One (1) Tent Space w/ no additional fee is allowed within each allotted 20' RV Space
- Portable Restroom Facilities will be made available in the North RV Lot

### 2) The Barn Area RV Lot: (Details include)

- Located in the Livestock/Small Animal Barn Area: 50 Available Spaces
- Cost: \$300
- One (1) 15' wide RV space
- 30 Amp electric service & Water Hookups
- The Barn Area RV Lot Spaces will be drawn by a lottery style drawing on April 1, 2019 at 12 noon via Facebook Live.

## 3 RV OPTIONS FOR YOU CHOOSE FROM

### 1) Purchase a North RV Lot Dry Camp Space

- Turn in a completed application by April 1<sup>st</sup> with a check for \$275 and you are guaranteed a reserved RV space in the North Lot.

### 2) Enter the lottery for the Barn Area RV Lot and select the North RV Dry Camp Lot as a secondary choice in case your name is NOT drawn in the lottery.

- Turn in a completed application by April 1<sup>st</sup> with a check for \$275. If your name is drawn in the lottery you will be guaranteed a reserved space in the Barn Area RV Lot and you will be required to pay the additional \$25 of the balance within 10 business days. If your name is NOT drawn in the lottery, you will be guaranteed a reserved space in the North RV Lot and will be paid in full.

### 3) Enter the lottery for the Barn Area RV Lot and select no secondary choice. If you choose this option and your name is NOT drawn in the lottery, you will receive a 100% refund.

- Send in a completed application with a check for \$300. If your name is not drawn in the lottery, the fair will issue you a 100% refund within 10 days of the lottery drawing and you will not have an RV Space at the 2019 Fair.

# Livestock Exhibitor RV Park Occupant Rules & Procedures

## I. RV LOT AREAS:

- i. North RV Dry Camp Lot: Capacity Limit: 125 RV Spaces
- ii. Barn Area RV Lot: 50 RV Spaces

## II. RATES:

- i. North RV Dry Lot: \$275
- ii. Barn Area RV Lot (w/ Hookups): \$300
- iii. Tent Camping: Available in Barn RV Area only (Limit of 4 Spaces) : \$100

## III. OCCUPANT PERIOD OF STAY LIMITATIONS

- i. Period of Stay: Saturday July 27, 2019 thru Monday August 5, 2019

## IV. SERVICES PROVIDED

- i. **North RV Dry Lot:** The space fee includes the following:
  - i. One (1) 20' wide RV Space
  - ii. One (1) Vehicle Parking Pass in the North RV Lot (Vehicle Parking will be located on the West Side of the Lot)
  - iii. One (1) Tent Space w/ no additional fee is allowed within each allotted RV Space
  - iv. Portable Restroom Facilities will be made available in the North RV Lot
- ii. **Barn Area RV Lot:** The Space fee includes the following:
  - i. One (1) 15' wide RV space
  - ii. 30 Amp electric service
  - iii. Water Hookups are available at each space.

## IV. ASSIGNED RV SPACE LOCATION / LOTTERY DRAWING

- i. Applications to purchase a space in the North Dry RV Lot will be accepted starting on March 18 @ 9:00 am at the Fair Office.
- ii. All applicants wishing to participate in the lottery drawing for the Barn Area RV Lot must have their completed applications submitted to the fair office by April 1<sup>st</sup> @ 12 noon.
- iii. The Barn Area RV Lot Trailers will be selected by a lottery drawing. If you wish to enter the lottery drawing please denote that as your first option on the application. The lottery will be selected on April 1, 2019 at 12 Noon via Facebook Live. The lottery results will be posted online on April 2<sup>nd</sup> and emailed to all applicants. The applicants selected in the lottery drawing are guaranteed a space in the Barn Area RV Lot. The fair staff will assign the specific RV space in the Barn Area for each lottery winner. In the case that you are not selected, you will have the option to purchase a space in the North RV Dry Lot.

## V. PROXIMITY LIMITATIONS

- i. The fair will accommodate the RV applicants that live 5 miles or more first and the under 5 miles will need to contact the fair office after April 15, 2019 for space availability in the North RV Dry Lot.

## VI. RV SIZE LIMITATIONS

- i. RV's will be limited to a maximum size of 36' from front to back not including the hitch and are subject to inspection upon entering the staging area. There are a limited number of spaces that have more depth and may allow for additional length per the exception and decision of fair management.

**VII. RV PARKING ARRIVAL & DEPARTURE PROCEDURES:**

- i. RV's will arrive on Saturday, July 27<sup>TH</sup> at your assigned time that you will receive in your RV Packet that will be mailed approximately 2 weeks prior to fair. The assigned times are done in groups so that we are able to get the RV's in their spaces in a somewhat organized and ease of parking. If you do not come at your assigned time there is no guarantee that you will be able to get in your assigned space. All RV's must be in place by Saturday at 7 pm.
- ii. All trailers must go in their spaces straight unless space is designated to be in a different direction.
- iii. All trailers must be backed or pulled all the way in their space to the line.
- iv. RV'S/Tents may depart Sunday, August 4<sup>th</sup>, until 10:00 am or after 7:30 pm. All RV Trailers and Tents must be off the fairground's premises by Monday, August 5<sup>th</sup> @ 8 pm. Trailers left on the fairgrounds after that time are subject to an additional daily rate fee and/or may be towed at the owner's expense.

**VIII. SUPERVISION/RESPONSIBLE PARTY**

- i. All junior exhibitors and anyone under the age of 18 MUST be accompanied by a parent/guardian or chaperone over the age of 25, excluding siblings.
- ii. One responsible chaperone (parent or leader) 25 years of age or older is required per trailer. Siblings are not considered chaperones no matter the age. No Junior Exhibitor, even if 18 or over, can stay without a chaperone. If there is no chaperone after 10:00 pm thru 6:00 am and your RV is checked you will not be able to reserve a RV space for future Yuba-Sutter Fairs and your trailer will need to be removed.

**IX. GENERAL RV PARK RULES**

- i. Recreational Vehicles (RVs) present on the fairgrounds may be removed from the premises at the owner's expense and no refund for the failure to comply with the RV Park Occupant Rules & Regulations. (Civil Code Section 799.22, 799.25 & 799.57)
- ii. One RV/Tent per camp space in the Barn Area RV Lot.
- ii. No firearms, weapons or illegal drugs are permitted on the fairgrounds. Fair Management reserves the right to determine what is considered a weapon.
- iii. No motorized scooters, razor scooters, bicycles, hoverboards, drones or skateboards are allowed on the fairgrounds or livestock area.
- iv. No smoking in the RV or Barn area. Smoking is allowed in designated smoking areas only.
- v. No trimming of trees, defacing or vandalizing fair property.
- vi. At no time may an extension cord be stretched across a road or fire lane to supply electricity to other RV's or stock trucks. No multiple tie-ins will be allowed. Electrical cords must be in good condition and extension cords must not interfere with foot traffic.
- vii. The speed limit inside the fairgrounds is 10 mph. No Speeding or reckless driving on the fairgrounds.
- viii. The roads around the RV areas must be kept clear so that fire and emergency vehicles can drive through at any time. The minimum width of these roads is twenty (20) feet.
- ix. Absolutely no gray water, sewage or effluent from sinks, portable toilets and any other plumbing fixtures are to be drained, dumped or leak directly upon or into ground surfaces. Pumping grey and black water from the holding tanks is acceptable if performed by a professional pumping service.
- x. Absolutely no livestock projects are allowed in the RV areas or west of Pig-a-dilly circle for the duration of the fair. Exercise animals in their respective barns or show rings only.

**V. PETS**

- i. Absolutely no dogs with the exception of service dogs or other pets are allowed on the fairgrounds or in RV trailer areas for the duration of fair.

**VI. RV OCCUPANT COURTESY**

- i. Noise should be kept to minimum at all times. No loud radios or music at anytime.
- ii. No outside appliances in RV spaces such as refrigerators, large TV's, etc.
- iii. Generators must be turned off by 10:00 pm in the Barn RV area. Generators must be turned off by midnight in the North Dry RV Lot.

- iv. All exhibitors should be in camp by 11:00 pm and not wandering in the barns or on the grounds.

**VII. ACCESS GATES**

- i. North RV Dry Camp Lot:
  - i. The "C" Street Gate is the only entry and exit gate for all RV's and Parked Vehicles located in the North Parking Lot.
- ii. RV's parked in the Barn Area will enter the fairgrounds through the Franklin Avenue Livestock Gate.

**VIII. VEHICLE PARKING IN NORTH RV CAMP LOT**

- i. North RV Dry Camp Lot:
  - i. One (1) Vehicle Parking Space is included with each RV Space in the North RV Dry Camping Lot.
  - ii. Vehicles will be required to be parked in the Vehicle parking lot located in the North RV Lot on the West side. This lot will be used and reserved only for the RV Camper Occupants of the North RV Dry Camp Lot.
  - iii. Additional parking permits are available for \$10. The purchaser and user of the parking permit must be an occupant of the North RV Dry Camp Lot. Limited number of additional parking spaces are available on a first come first served basis. Limit one (1) additional parking pass per family if parking space is available.

**IX. VIOLATION OF RULES**

- i. Any violation of above rules may result in immediate ejection from the Fairgrounds, loss of privilege to sell in the Jr. Livestock Auction, entries removed from Fairgrounds, and loss of premiums.

**Acceptance of Terms & Conditions** – Must be signed and submitted with RV Application.

By signing this form, I hereby acknowledge that I have received, read and understand the Rules and Procedures for the Yuba-Sutter Fairgrounds Livestock Exhibitor RV Park and accept responsibility for all occupants in the assigned RV Space and that any violation of said Rules and Regulations will result in immediate removal from the Yuba-Sutter Fairgrounds RV Park and other action deemed appropriate by the Management.

The State of California, 13<sup>th</sup> District Agricultural Association (DAA) owns this property. The RV occupant accepts camping privileges with the understanding that he/she does hereby release the DAA, it's officers and employees, of all liability for loss or damage to property and injury to his/her person arising out of his/her use of its camping facilities and agrees to defend and indemnify the DAA, its officers and employees, against all claims resulting from loss or damage to property or injury to the person of any member of the family or guest of the registered camper arising out of the use of the camping facilities. In the case of a defaulting occupant, the RV may be removed from the premises for the reasons specified in the California Civil Code Section 799.22. "Defaulting occupant" means an occupant who fails to comply with reasonable written rules and regulations of the park given to the occupant upon registration.

I have read and understand the above rules and regulations and I will abide by the above. I understand I am responsible for all persons, property, and chaperoned individuals associated with my RV Space during my stay in the RV Area.
