

What's New in 2021

Please see below for some of the new updates and changes for the 2021 Junior Livestock Program. The significant updates are listed below as a quick point of information for planning purposes.

- ✓ **MARKET BEEF WEIGHT LIMITS: Increased Minimum Weight Limit**
 - 2021 Fair Weight Limits: 1050 to 1400 lbs. (No top disqualification weight. Top sale weight is 1400)
 - 2022 Fair Weight Limits: 1100 to 1450 lbs. (No top disqualification weight. Top sale weight is 1450)
- ✓ **MARKET GOAT WEIGHT LIMITS: Increased Minimum Weight Limit**
 - 2021 Fair Weight Limits: 65 to 115 lbs. (No top disqualification weight. Top sale weight is 115)
- ✓ **MARKET TURKEY WEIGHT LIMITS: Increased Minimum Weight Limit**
 - 2021 Fair Weight Limits: 15 to 35 lbs. (No top disqualification weight. Top sale weight is 35)
 - 2022 Fair Weight Limits: 18 to 35 lbs. (No top disqualification weight. Top Sale weight is 35)
- ✓ **BRED REPLACEMENT HEIFERS: Calving Date Range Updated**
 - Heifers must be bred to calve between August 1st, 2021 thru December 1st, 2021 and be verified by preg-checking within 10 days of arrival at the fair.
- ✓ **RABBIT & CHICKEN PENS & SHOWRING LOCATION**
 - The Rabbits and Chicken will be penned and showed in the Expo Hall Building. Upon arrival take the animals to Expo Hall.
- ✓ **SWINE ARRIVAL & WEIGH-IN PROCEDURE**
 - Swine will be scheduled to arrive on Sunday and Monday between 7 am -1 pm. Swine will be weighed-in and health checked upon unloading from the trailer. Clubs & Chapters will be scheduled within an allotted time period for arrival of swine.
- ✓ **SWINE SHOW**
 - The entire swine show will take place on Wednesday, June 23rd starting at 8am. There will be a 30-minute break in between the 4-H and FFA Shows.
- ✓ **SHEEP SHOW**
 - The sheep show will take place in the Main Show Pavilion Arena on the south end.
- ✓ **LOCAL RULE # 14 UPDATED:**
 - Previous Local Rule #14: If an exhibitor is disqualified at another California Fair they will be ineligible to show at the Yuba-Sutter Fair for at least one (1) year, if not disqualified from exhibiting permanently. This may also apply to siblings if the violation was associated to ethical practices.
 - Updated Local Rule #14: If an exhibitor has been disqualified at any local, county, regional, state or national show they will be ineligible to exhibit at the Yuba-Sutter Fair for at least one (1) year, if not disqualified from exhibiting permanently. This may also apply to siblings if the violation was associated to ethical practices.
