Livestock Exhibitor RV Park Occupant Rules & Procedures

I. RV LOT AREAS:

- i. Garden Highway and Barn Area RV Lot: 84 RV Spaces
- ii. North Livestock RV Dry Camp Lot: Capacity Limit: 60 RV Spaces

II. RATES:

- i. North Livestock RV Dry Camp Lot: \$300
- ii. Garden Highway and Barn Area RV Lot (w/ Hookups): \$450
- iii. Tent Camping: Available in Barn RV Area only (Limit of 2 Spaces): \$150

III. OCCUPANT PERIOD OF STAY LIMITATIONS

- i. Period of Stay: Saturday, June 20, 2026 thru Monday, June 29, 2026.

IV. SERVICES PROVIDED

- i. **Garden Highway and Barn Area RV Lot:** The Space fee includes the following:
 - i. One (1) 22' wide RV space
 - ii. 30 Amp electric service
 - iii. Water Hookups are available at each space.
- ii. **North Livestock RV Dry Camp Lot:** The space fee includes the following:
 - i. One (1) 20' wide RV Space
 - ii. Portable Restroom Facilities will be made available in the North Livestock RV Dry Camp Lot

IV. APPLICATION PROCESS:

- i. Garden Highway and Barn Area RV Park Occupants from the previous years will have the first right of refusal to an RV Space for the upcoming fair. If payment is not received by Friday, February 13th, by 4 pm the RV Space will be automatically forfeited.
- ii. Starting on Friday, February 20th, Garden Highway and Barn Area RV spaces that are available will be offered to the Families in the Dry Lot based on how long you have been camping in the Dry Lot.
- iii. Dry Lot spaces if any are available, will be offered starting Monday, March 2nd.
- iv. Applications are available online for download at www.ysfair.com on the Livestock Exhibitors page.

V. ASSIGNED RV SPACE LOCATION

- i. The spaces will be assigned by the fair staff.

VI. RV SIZE LIMITATIONS

- i. RV's will be limited to a maximum size of 36' from front to back not including the hitch and are subject to inspection upon entering the staging area. There are a limited number of spaces that have more depth and may allow for additional length per the exception and decision of fair management.

VII. RV PARKING ARRIVAL & DEPARTURE PROCEDURES:

- i. RV's will arrive on Saturday, June 20th at your assigned time that you will receive in your RV Packet that will be mailed approximately 2 weeks prior to fair. The assigned times are done in groups so that we are able to get the RV's in their spaces in a somewhat organized and ease of parking. If you do not come at your assigned time there is no guarantee that you will be able to get in your assigned space. All RV's must be in place by Saturday, June 20th, at 7 pm.
- ii. All trailers must go in their spaces straight unless space is designated to be in a different direction.
- iii. All trailers must be backed or pulled all the way in their space to the line.
- iv. RV'S/Tents may depart Sunday, June 28th until 10:00 am or after 7:30 pm. All RV Trailers and Tents must be off the fairground's premises by Monday, June 29th at 8 pm. Trailers left on the

fairgrounds after that time are subject to an additional daily rate fee and/or may be towed at the owner's expense.

VIII. SUPERVISION/RESPONSIBLE PARTY

- i. All junior exhibitors and anyone under the age of 18 **MUST** be accompanied by a parent/guardian or chaperone over the age of 25, excluding siblings.
- ii. One responsible chaperone (parent or leader) 25 years of age or older is required per trailer. Siblings are not considered chaperones no matter the age. No Junior Exhibitor, even if 18 or over, can stay without a chaperone. If there is no chaperone after 10:00 pm thru 6:00 am and your RV is checked you will not be able to reserve a RV space for future Yuba-Sutter Fairs and your trailer will need to be removed.

IX. GENERAL RV PARK RULES

- i. Recreational Vehicles (RVs) present on the fairgrounds may be removed from the premises at the owner's expense and no refund for the failure to comply with the RV Park Occupant Rules & Regulations. (Civil Code Section 799.22, 799.25 & 799.57)
- ii. One RV/Tent per camp space in the Garden Highway and Barn Area RV Lot.
- ii. No firearms, weapons or illegal drugs are permitted on the fairgrounds. Fair Management reserves the right to determine what is considered a weapon.
- iii. No motorized scooters, razor scooters, bicycles, hoverboards, drones or skateboards are allowed on the fairgrounds or livestock area.
- iv. No smoking in the RV or Barn area. Smoking is allowed in designated smoking areas only.
- v. No trimming of trees, defacing or vandalizing fair property.
- vi. At no time may an extension cord be stretched across a road or fire lane to supply electricity to other RV's or stock trucks. No multiple tie-ins will be allowed. Electrical cords must be in good condition and extension cords must not interfere with foot traffic.
- vii. The speed limit inside the fairgrounds is 10 mph. No Speeding or reckless driving on the fairgrounds.
- viii. The roads around the RV areas must be kept clear so that fire and emergency vehicles can drive through at any time. The minimum width of these roads is twenty (20) feet.
- ix. Absolutely no gray water, sewage or effluent from sinks, portable toilets and any other plumbing fixtures are to be drained, dumped or leak directly upon or into ground surfaces. Pumping grey and black water from the holding tanks is acceptable if performed by a professional pumping service.
- x. Absolutely no livestock projects are allowed in the RV areas or west of Pig-a-dilly circle for the duration of the fair. Exercise animals in their respective barns or show rings only.

V. PETS

- i. **Absolutely NO** dogs with the exception of service dogs or other pets are allowed on the fairgrounds or in RV trailer areas for the duration of fair.

VI. RV OCCUPANT COURTESY

- i. Noise should be kept to minimum at all times. No loud radios or music at anytime.
- ii. No outside appliances in RV spaces such as refrigerators, large TV's, etc.
- iii. Generators must be turned off by 10 pm in the Garden Highway and Barn RV area. Generators may be used in the North Livestock RV Dry Camp Lot.
- iv. All exhibitors should be in camp by 11 pm and not wandering in the barns or on the grounds.

VII. ACCESS GATES

- i. North Livestock RV Dry Camp Lot:
 - i. The "C" Street Gate is the only entry and exit gate for all RV's and Parked Vehicles located in the North Livestock RV Dry Camp Parking Lot.
 - ii. Occupants in the North Dry Lot will have walk-thru access on to the fairgrounds through two gates, Gate 15 and Gate 16.
 - iii. Gate 15 Scheduled Walk-thru Access:
 1. Will be accessible starting at 5 am through 11 pm from Sunday through Thursday.

- 2. Will be accessible from 5 am to 6 pm from Friday through Sunday. Will be closed starting at 6 pm for Grandstand Event Arena access and safety needs. Access will only be available at Gate 16 after 6 pm on Friday thru Sunday.
- iv. Gate 16 Scheduled Walk-thru Access:
 - 1. Will be accessible 24/7 starting on Sunday.
- ii. RV's parked in the Garden Highway and Barn Area will enter the fairgrounds through the Franklin Avenue Livestock Gate, Gate 8.

VIII. VEHICLE PARKING IN NORTH RV CAMP LOT

- i. North Livestock RV Dry Camp Lot:
 - i. Vehicles will be required to be parked in the specified vehicle parking area located on the East side north of the North Livestock RV Dry Camp Lot. The west side of the North Parking lot will be used for employee, sponsor, entertainment and vendor parking purposes only. **Absolutely NO vehicles may be parked by RV's.**
 - ii. Parking permits are available for North Livestock RV Dry Camp Lot for \$20. The purchaser and user of the parking permit must be an occupant of the North Livestock RV Dry Camp Lot. **Only one (1) parking pass per RV for the North Parking Lot will be issued (if purchased) with a designated area to park.**
 - iii. **Absolutely NO vehicles may be parked in the lot assigned for RV Parking. Failure to comply with this rule will result in disqualification of all the exhibitor's entries and loss of all premiums and auction proceeds.**

IX. VIOLATION OF RULES

- i. Any violation of above rules may result in immediate ejection from the Fairgrounds, loss of privilege to sell in the Jr. Livestock Auction, entries removed from Fairgrounds, and loss of premiums.

Acceptance of Terms & Conditions – Must be signed and submitted with RV Application.

By signing this form, I hereby acknowledge that I have received, read and understand the Rules and Procedures for the Yuba-Sutter Fairgrounds Livestock Exhibitor RV Park and accept responsibility for all occupants in the assigned RV Space and that any violation of said Rules and Regulations will result in immediate removal from the Yuba-Sutter Fairgrounds RV Park and other action deemed appropriate by the Management.

The State of California, 13th District Agricultural Association (DAA) owns this property. The RV occupant accepts camping privileges with the understanding that he/she does hereby release the DAA, it's officers and employees, of all liability for loss or damage to property and injury to his/her person arising out of his/her use of its camping facilities and agrees to defend and indemnify the DAA, its officers and employees, against all claims resulting from loss or damage to property or injury to the person of any member of the family or guest of the registered camper arising out of the use of the camping facilities. In the case of a defaulting occupant, the RV may be removed from the premises for the reasons specified in the California Civil Code Section 799.22. "Defaulting occupant" means an occupant who fails to comply with reasonable written rules and regulations of the park given to the occupant upon registration.

I have read and understand the above rules and regulations and I will abide by the above. I understand I am responsible for all persons, property, and chaperoned individuals associated with my RV Space during my stay in the RV Area.
